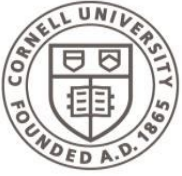

## **MPS Information Science Early Admit Petition**

### **I. Introduction**

The MPS in Information Science lies on the boundary between the social sciences and technology. Its emphasis is on how people interact with technology and information in digital forms. It is intended for students with a social science background who wish to develop strong technical understanding, or for students with a technical background who wish to study advanced topics in the social sciences.

We offer qualified Cornell undergraduates the opportunity to begin work towards the MPS degree in their final semester of undergraduate study. This allows students to receive a MPS degree in just one semester. We will be looking for students who will have a bachelors degree in Information Science (B.A.) or Information Science, Systems and Technology (B.S.); or a bachelors degree with a minor in Information Science and a major in Computer Science (B.A.or B.S.), Operations Research and Information Engineering (B.S.), or Communications (B.S.). Students who meet our written standards or have similar preparation and have demonstrated the skills needed to be successful in the program may also be considered. The students cannot count courses applied to the MPS in Information Science toward their undergraduate degree, or any other degree program, or vice versa. No courses taken prior to being admitted to the MPS program will count towards the MPS degree.

### **II. Requirements for the Early Admit Petition**

- a. Have at least one but no more than eight credits remaining to complete their undergraduate degree requirements.
- b. A cumulative GPA of 3.2 or better
- c. Must finish all undergraduate requirements while registered with their undergraduate colleges

### **III. MPS Program review of Petition**

Once the Early Admit petition is reviewed and approved a formal letter will be sent to the student from the MPS Director. Instruction on what term to submit a formal MPS admission application for will be noted in the letter.

### **IV. Admission to the program**

Acceptance of the Early Admit Petition does not guarantee admission into the MPS program. Students are required to submit a formal Graduate School application and will be reviewed with the entire pool of applicants. If accepted all students final Undergrad transcript will be reviewed and if the student has not performed in comparison to prior semesters or the GPA is lower than 3.2 the admission offer will be withdrawn.
